Russian official expresses confidence dialogue can resolve

MOSCOW.AGENCY

Russian President Vladimir Putin's economic envoy Kirill Dmitriev has expressed confidence that Moscow and Washington can resolve their differences through dialogue, reports RT.

The statement comes as US Special Envoy Steve Witkoff held a meeting with Putin, with the former holding talks with the Russian leader on reaching a settlement with Ukraine over Trump's threats to impose 100% sanctions on Moscow, should it fail to reach a peace settlement with Kyiv.

For its part, Russia has downplayed the threat of sanctions, stating that its long years of having stayed under Western embargo has made it develop an 'immunity' to sanctions, adding that additional sanctions mean nothing for its economy, even as the US President has acknowledged Moscow's ability to skirt past the sanctions.

The Kremlin has also mocked the POTUS' deadline manoeuvre, with former Russian President and now Chief of National Security Council, Dmitry Medvedev, having engaged in a furious battle of words with Trump over the issue, resulting in the US' deploy-

ment of nuclear submarines. In a post on X on Wednesday, Dmitriev, who is CEO of the Russian Direct Investment Fund (RDIF), thanked his followers for their "kind wishes for a successful visit of Steve Witkoff to Moscow," adding that "Dialogue will prevail". Dmitriev was also part

of the Russian delegation which welcomed Witkoff at Vnukovo Airport, and the two were later seen walking through Zaryadye Park near the Kremlin.

Later in the day, Witkoff held face-to-face talks with Putin, which lasted around three hours.

US may not impose sanctions on Russia: Reports

The United States may not impose sanctions against Russia after the deadline for a Ukraine peace deal announced by President Donald Trump expires on Friday, the New York Post reported, citing a source familiar with the matter. Trump previously said that he would impose 100 percent tariffs on Russian goods and secondary sanctions against countries purchasing Russian oil if a cease-fire agreement between Russia and Ukraine isn't reached within 50 days. In late July, he decided to cut the timeline for a Ukraine peace deal from 50 to 10 days. Trump added that if negotiations fail, he intends to impose import tariffs, though he expressed uncertainty about whether this would affect Russia. A source familiar with the discussions told the New York Post that sanctions are not inevitable when the deadline set by Trump expires on Friday, adding that for Trump, concluding a deal is "always the president's preferable outcome," and the US presidential administration is "pushing hard" for it.

Putin-Witkoff talks noted that both sides managed to hold a constructive and productive conversation which focused on the Ukraine conflict and "prospects for US-Russia strategic cooperation."

Hundreds of structures at risk by wildfire in Central California

LOS ANGELES.AGENCY Hundreds of structures are threatened by a fast-moving wildfire that has scorched over 82,000 acres (about 332 square km) in less than five days in Central California, authorities said Tuesday.

The wildfire, dubbed the Gifford Fire, broke out Friday afternoon when four separate ignitions along a California highway merged into a single wildfire currently burning on the Santa Lucia Road in both San Luis Obispo and Santa Barbara counties, according to the U.S. Forest Service and the California Department of Forestry and Fire Protection.

Authorities said that the blaze is threatening more than 870 structures and was only 7 percent contained as of Tuesday morning.

US department of health cancels over 1,800 research grants

MOSCOW.AGENCY

The US National Institutes of Health (NIH), part of the US Department of Health, canceled over 1,800 research grants from February to June 2025, which is a violation of the country's laws, the US Government Accountability Office (GAO) said. "Congress appropriated amounts to the National Institutes of Health (NIH) to carry out various research objectives for fiscal year 2025. In accordance with several executive orders, the Department of Health



and Human Services (HHS) and its agencies, including NIH, began canceling existing grants. Following these directives, the National Institutes of Health (NIH) terminated over 1,800 grants between February 2025 and June 2025," the GAO said in a statement. The statement added that between February and June of the 2025 fiscal year, USD 8 billion less was allocated

for research than for the same period in 2024. "As explained below, we conclude that HHS violated the ICA when it withheld funds from obligation and expenditure," the report said. In late March, Axios reported that the Health Department had canceled more than USD 12 billion in health care grants. According to the news portal, the grants were spent on COVID-19 testing, vaccinations, and health equity. The ministry also canceled grants from the Substance Abuse and Mental Health Services Administration.

गाजीपुर में गंगा के उफान ने मचाई तबाही, श्मशान घाट डूबने से सड़कों पर हो रही अंत्येष्टि

गाजीपुर (एजेंसी)

उत्तर प्रदेश के गाजीपुर जिले में गंगा नदी उफान पर है। गंगा का जलस्तर खतरे के निशान से एक मीटर से अधिक ऊपर पहुंच गया है, जिसके



चलते जिले की पांच तहसीलों के करीब 60 गांवों का जनजीवन पूरी तरह प्रभावित हो गया है।

बाढ़ का पानी गांवों तक ही सीमित नहीं रहा, बल्कि श्मशान घाटों को भी अपनी चपेट में ले लिया है। गाजीपुर के श्मशान घाट पूरी तरह पानी में डूब चुके हैं, जिसके कारण अंत्येष्टि के लिए लोग सड़कों और रियायशी इलाकों का सहारा ले रहे हैं। इससे

लोगों को भारी परेशानियों का सामना करना पड़ रहा है। गाजीपुर के साथ-साथ मऊ, बलिया और आजमगढ़ से प्रतिदिन शव अंत्येष्टि के लिए लाए जाते हैं। रोजाना 15 से 20 शवों का अंतिम संस्कार किया जाता है,

लेकिन अब यह कार्य सड़कों और रियायशी क्षेत्रों में हो रहा है। सड़कों पर जल रही चिताओं से उठने वाला धुआं स्थानीय लोगों के लिए परेशानी का सबब बन गया है। इसके अलावा बुनियादी सुविधाओं का भी अभाव है। लोगों का कहना है कि वे दूर-दराज से आते हैं और अंत्येष्टि के लिए दो से तीन घंटे इंतजार करना पड़ता है। इस दौरान उन्हें बैठने

की कोई उचित व्यवस्था नहीं मिल रही। कई यात्रियों ने जिला प्रशासन और नगर पालिका पर लापरवाही का आरोप लगाया है। उनका कहना है कि गंगा का जलस्तर बढ़ने के बावजूद श्मशान घाट पर कोई वैकल्पिक व्यवस्था नहीं की गई है।

इस मामले पर नगर पालिका के अधिशासी अधिकारी धीरेंद्र कुमार राय ने बताया कि बाढ़ प्रभावित इलाकों में शुद्ध पेयजल के लिए टैंकर लगाए गए हैं। सफाई व्यवस्था को दुरुस्त करने के निर्देश दिए गए हैं और ब्लीचिंग पाउडर का छिड़काव कराया जा रहा है ताकि संक्रमण का खतरा न हो। श्मशान घाट की समस्या पर उन्होंने कहा कि चिताओं की राख को नष्ट करने का कार्य भी नगर पालिका द्वारा कराया जाएगा। लोग प्रशासन की कोशिशों को नाकामि मान रहे हैं। बाढ़ के इस कहर ने न केवल लोगों के दैनिक जीवन को प्रभावित किया है, बल्कि मृतकों की अंतिम विदाई को भी कठिन बना दिया है।

अखिलेश यादव पर भाजपा विधायक राजेश्वर सिंह का तंज, पीडीए का मतलब है परिवार
